4	<ul> <li>Treasurer Chris presented the Finance Report: <ul> <li>Fortunate with the grants</li> <li>Note that the Charity did not receive any transfer from WGVRA last year due to Covid</li> <li>Chris pointed out that the Charity costs are about £3,000 per year</li> <li>Costs on the refurbishment were mostly those connected with the new windows</li> <li>Income in the year and including donations was approx £2,000</li> <li>Recommendation for a £1,000 transfer to the Peace Centre Charity</li> <li>The Treasurer and Committee thanked Allan for his work as auditor</li> <li>A discussion was had around the bonfire (of garden waste) and that 17 residents had keys to the gate. This number is more than the members of the WGVRA.
